No election was held during the year. The term of office of the Elected Members was extended for a period of six months beyond 10.02.2020 vide MoD letter No.14(8)/2019-D(Q & C) dated 5th February 2020 for which the MoD instructions were circulated vide Circular Agenda No. 1 dated 10.02.2020 and noted by the Board vide CBR No.2 dated 11.02.2020.
