Public Notice

Whereas the Central Government vide Gazette notification SRO No. 3(E) dated 17.02.2023, in exercise of the Powers Conferred by Sub Section (1) of Section 15 of the Cantonments Act, 2006, directs the 30th April 2023 as the date on which the Ordinary Elections to the Shillong Cantonment Board.

Whereas the Central Government vide Gazette notification SRO No. 6(E) dated 26.03.2021, in exercise of the powers conferred by Sub Rule 3 of Rule (5) of the Cantonment Electoral Rules, 2007, already notified the wards reserved for Women.
