Traders/ Manufacturers/Vendors/Contractors/suppliers etc who have failed to apply the same during the financial year 2022-23 are hereby directed to apply for trade license w.e.f from the date of publication of this Notice failing which action will be taken as per the following section:-

1. Under Section 281 of the Cantonments Act, 2006. "Whoever carries any trade, calling or occupation for which a licence is required without obtaining a licence.....shall be punishable with fine which may extend to five thousand rupees and, in the case of a continuing offence, with an additional fine which may extend to five hundred rupees for every day after the first during which the offence is continued."

Further, Traders/ Manufacturers/Vendors/Contractors/suppliers etc already having **previous year** trade licence are also directed to **renew their respective trade licence** through online mode from Cantonment Board official website *www.shillong.cantt.gov.in*. New/ Fresh applicants who have opened new shops/trades will also have to submit their trade licence application in online mode only from Cantonment Board official website *www.shillong.cantt.gov.in*.

- 6. Occupancy Document (Previous Trade License Receipt/Property Tax Bill/Water Bill from the said House/ Holding No).

N.B: Citizen who are facing problem in applying Trade License through E-Chhawani/finding difficulty in making payment online/facing problem in uploading the document are hereby advise to approach the office of Shillong Cantonment Board along with requisite documents on any working day for necessary action. Assistance will be provided for applying Trade License.
